
Trends in School Safety and Order

By some measures, serious violence in schools has declined

By most measures, low-level aggression, disruptive behaviors, and bullying remain at troubling levels


The complexity of measuring these trends is examined throughout the special issue of *Educational Researcher*

Measures of Students Threatened or Injured with a Weapon, or Having Missed School Due to Safety Concerns, Have NOT Declined.




"During 1993–2007, a significant linear increase occurred in the percentage of students who did not go to school because of safety concerns (4.4%– 5.5%)" (Eaton et al., 2008).





Bullying Remains Pervasive


Shift in Focus From School Violence to School Safety


School violence is not a single problem with a simple solution


Need to shift focus to broader landscape of order and emotional and physical safety

Common needs for students and schools:

- Positive investment and engagement
- Physical & psychological well-being
- Academic & social progress







School Safety and Order Matters: Psychological Well-Being

Day-to-day bullying, intimidation, and incivility in schools is a primary problem, driving students' fear, anxiety, and avoidance of school to a much greater degree, compared to theft and physical attack (Mayer, 2010)

Most importantly, **measures of incivility explain almost double the variance** (31–45% vs. 17–25%) **in students' fear, anxiety, and avoidant behaviors**, compared to theft and attack, when tested using alternate measurement models.

School Safety and Order Matters: Analogy To Child Neglect

Severe physical child abuse is analogous to school shooting

- Severe harm
- High profile and obvious
- Quick, visible systemic response

Long-term child neglect is analogous to long-term bullying, intimidation, and incivility in schools; toxic school environments

- Harm is real, substantial
- Not so obvious
- Marginal systemic response


Long-term bullying, intimidation, and incivility in schools that is under addressed constitutes a form of **systemic educational neglect** (Mayer & Furlong, 2010)






